



The treatment of hyperactivity and addictions

A course of homeopathic treatment with

MUSCARSAN with good prospects

Editor's preface:

The successes achieved up to now with the SANUM remedy MUSCARSAN (active ingredient: amanita muscaria from toadstools) have led to this remedy being made available immediately in 6X tablet form, in addition to the 6X drops and 4x ampoules for injection which were already available. As described in the repertory of SANUM remedies, MUSCARSAN in all its forms has a large field of application, which is now being further enlarged by the fact that the new tablet form which contains no alcohol is particularly suited to those patients who must avoid taking medications which include alcohol.

*„Each effective remedy arouses in the human organism a type of illness of its own - the more effective the medication, the more characteristic the illness. For the illness to be cured, one should use that remedy which is capable of producing another artificial illness which is as similar as possible to the actual illness, and this will then be healed: similia similibus curentur.“

Every practitioner knows about the difficulty of using psychotherapy to bring a person with mental problems (*angst*) onto an even keel where the *angst* or the problem are tolerable, or simply suppressing the *angst* through the use of medication, without the patient losing his/her creativity, courage and joy in

living. This is even more the case for people whose „nerves“ or psyche are under strain for a variety of reasons or who perhaps because of this become addicts. It is therefore necessary to present once more the basics of homeopathic substances which are alleged to have a „tranquilliser“ effect. Only in this way can it be understood that substances prepared according to homeopathic principles can produce an effect which clears up psychological problems or acts as an analgesic.

The Arndt-Schulz rule says that small doses of a remedy stimulate, moderate doses benefit, but high doses inhibit. In Hahnemann's time this rule was a fundamental mainstay of homeopathy, and this is still the case. One further factor is that homeopathy does not produce an effect only through the material aspect of a substance, but above all with the non-material component, the aura (energy flow). This can also be called the oscillation pattern. According to modern teaching, the homeopathic substance enters the body by means of informative oscillation images in resonance with particular organs or cell membranes.

If then a substance shows an affinity to particular organs or organ cells, it will trigger off chemical reactions with its material component. These reactions can turn out to be beneficial, inhibitory, moderately destructive or highly toxic, according to the substance

concerned. With the non-material, i.e. energy, level it works on another plane and produces primarily no chemical reactions.

Therefore it should not be a surprise to anyone if toxic substances prepared according to homeopathic principles have the opposite effect to the known toxic symptoms. This is demonstrated in an astounding manner by the Muscarin phenomenon. Muscarin is the poison found in toadstools (*Amanita muscaria*) and is regarded as highly toxic. Table 1 shows the appropriate comparison.

As can be seen from table 1, the substance muscarin produces in humans a whole series of symptoms which on the whole can be ascribed to the stimulation of the postganglionic cholinergic receptors (parasympathicus). Therefore the use of MUSCARSAN 6X, the homeopathic remedy derived from *Amanita muscaria*, allows a positive influence to be made on a large number of aches and pains associated with disease which ensue from the remedy picture. When we consider this more closely, it is those syndromes with symptoms to which until now much too little attention has been paid, which can be treated successfully with MUSCARSAN 6X.

From the practical viewpoint, in a practice specialising in gastroenterology and paediatrics the main areas of treatment with

MUSCARSAN would be as follows:

The effectiveness of MUSCARSAN 6X in addiction can be very easily verified. One of the main clinical phenomena of enteral allergy is addictive behaviour. „I love my allergen“ or the opposite „I hate it - I refuse it“. The latter form makes it easier to stick to dietary prescriptions, the former makes it difficult for the practitioner to be involved. It takes a lot of time and much persuasion to release somebody who has a craving for chocolate from their addiction. But this is also evident in other

food addictions. The extreme case is addiction to alcohol.

As can be seen from Table 2, 134 persons with a craving for chocolate (up to 3 bars of milk chocolate per day) were given a

course of treatment with MUSCARSAN 6X. After two weeks, 112 of the subjects declared that they had completely stopped taking the substance to which they were addicted. In order to avoid the possibility of objections to the findings on the grounds of chance, all 134 patients (27 of them young people from 12 to 18 years of age) were again checked after two months. This showed that in the meantime another five subjects who had an enteral allergy were also managing without chocolate. The rest (8 teenagers / nine adults) could not keep to the prescribed diet.

The check was carried out using the IgA test. IgA is formed by the intestinal mucous membrane. The better the mucosa enteralis recovers, the better the serological level. The failure group consists of people who are addicted to several substances and who therefore also regularly take large quantities of analgesics

or alcohol. In this group one must reckon in terms of longer periods of time, for in the second period of weeks they experience only a



reduced compulsion to eat chocolate or take tablets.

A further group consists of patients with school headaches, a type of migraine pain caused by strain in school. This can also be dismissed as autonomic strain on the nervous system, but for the individual subject it is an extremely unpleasant condition. Mostly the patient also complains of „tired eyes“, and his thought processes slow down. To make a firm diagnosis, EEGs, eye tests and X-rays of the nasal sinuses were arranged, but in all the subjects the results of these were normal. It is very impressive to note how the headaches cease when MUSCARSAN 6X is prescribed. Only one patient reported a significant improvement only after three weeks, and in three patients (18a, 18a, 17a) no improvement was noted. All three children come from an environment where their parents are very dominating, and in addition two of these children are repeating a year at school. It is questionable whether in these cases it is really only a case of strain brought on by school.

A particular facet of strain on the autonomic nervous system is the presence of gastralgia and meteorism. These phenomena can occur at any age and are mostly a reason for looking for allergies and intestinal mycoses. Such conditions can be very easily recognised by the exact time they appear. These conditions are always experienced around the same time, they can even occur during sleep. In the course of longer psychological exploration one notices their connection to events which have remained suppressed in the subconscious (mostly from early childhood). Here too the prescription of MUSCARSAN is indicated, along with the usual dietary prescriptions.

A tried and tested treatment plan

To sum up, it must be emphasised that there are no differences in effectiveness between the drops and the tablets.

MUSCARSAN 6X drops:
Children and teenagers (8 to 18

years of age) 7 to 10 drops twice daily, adults 10 to 15 drops twice daily.

MUSCARSAN 6X tablets:
children and teenagers 1/2 to 1 tablet twice daily, adults 1/2 to 1 tablet two to three times daily.

The many types of conditions which appear in the palette of muscarin symptoms are very widespread and in the experience of the author are becoming much more common. In order to recognise this, one must however go into this group of conditions intensively at some stage. When checking the medical history of patients with so-called psychovegetative disorders, one quickly becomes aware of the individual phenomena of the muscarin phenomenon. Here it is worth simply prescribing MUSCARSAN 6X. No side-effects have been observed.
